




Downend & Bromley Heath Community Plan



Welcome to the Downend and Bromley Heath Community Plan

The Plan reflects the priorities expressed by local residents and it looks ahead at what can be done to develop, sustain and improve Downend and Bromley Heath as a healthy, safe and lively place in which to live, work and play over the next decade.

It was presented to Downend and Bromley Heath Parish Council in spring 2011 and at the Annual Parish Meeting on 28th April, 2011. It was launched at community events in the summer 2011.

In the following pages are the Key Findings from many different consultations, including a detailed questionnaire sent to every household in the Parish. The responses were used to produce the Action Plan, on pages 4 to 7, which will be implemented with the support of Downend and Bromley Heath Parish Council and other partners. However, nothing can be achieved without the help of enthusiastic volunteers from the community.

We expect the Plan to evolve to reflect changing circumstances. Do give it your support and some of your time to keep it alive and relevant over the next ten years.

The Community Plan Team hopes you enjoy browsing through the Plan and encourages you to keep it to hand for reference.



Downend and Bromley Heath today is town and country, a growing, modern, diverse, suburban community with a countryside history on the edge of a large provincial city. Older residents can remember when there were farmers' fields and apple orchards where there are now houses and supermarkets. With nearly 12,000 residents, it is also one of the larger communities in the West to develop a Community Plan.



Why Have a Community Plan? Many parishes across the country have taken up the challenge to involve their communities in unique plans that celebrate the present and give a realistic shape

to their communities' aspirations for the future. Our plan embodies how residents see and value where they live, work and play. It also sets out how they would like the community to develop over the next five to ten years and provides priorities for the Parish Council, South Gloucestershire Council and other agencies to respond to.

Finding out your views and putting together the Plan.

With the support of the Parish Council, an independent group of local people who care about our community conducted a survey of all residents and have used the responses to develop this Community Plan.

The group started its work in 2009 with a short survey to discover what might be the main issues for residents. This provided the basis for the more detailed **Your Community - Your Say** questionnaire which was delivered to every household in early summer 2010. The completed questionnaires were collected from houses and at collection points in the area and the electronic questionnaire on the Parish Council's website stayed live throughout the summer. The aim was to give every resident the best opportunity to have an input into the Plan.

Almost 1500 people of all ages responded to **Your Community - Your Say** and the Plan Team has considered more than 50,000 separate answers.

Key Findings from the Questionnaire

Community

Residents liked Downend and Bromley Heath and see it as a good place to live. However, three main concerns emerged: litter; street, pavement and lane clearing; and the limited range of local shops.

It was clear that residents generally preferred their news and information about the community in printed form.

Many of you wanted better local provision, for example shops and a Farmers' Market. We will need to consider how to deal with this as these have not been well supported in the past.

Residents acknowledged the wide range of activities in Downend and Bromley Heath. Comments suggest that people do not always know where to find out about community facilities, activities and events.

Street and lane lighting, regular and routine policing and Neighbourhood Watch were considered to be very important. There is clearly a strong wish to maintain and improve Downend and Bromley Heath as a safe place to live.

Young People

The need for a comprehensive directory of all the existing activities, facilities, groups and clubs is a high priority, as it became very clear that respondents were unaware as to what is currently available to them.

Many of you, across all ages, expressed a strong wish for more extensive and improved play and activity equipment and facilities

for children and young people. There was an interest in a broader range of organised outdoor sporting activities.

Across the age range there were requests for more, safer places for young people to meet and for venues where parents and grandparents with younger children could socialise. There was some enthusiasm for ecologically and environmentally pro-active fun groups.

Parks, Open Spaces and Environment

Our seven Open Spaces are well used by residents, especially George V Playing Field and Bromley Heath Park. Some people indicated that they did not know where the Parks and Open Spaces were.

There were suggestions for better play facilities for young people and wide support for more places to sit in the parks, and at the shops.

Litter was a strong concern in the parks, local shopping areas and along some paths and lanes. Many people said they would be willing to pick up litter occasionally.

Dog fouling in parks and on pavements is another major concern. Some dog owners commented that the behaviour of a few reflects badly on all dog owners.

Traffic, Highways and Transport

This section received a high number of responses. Residents are concerned about transport and related matters: this probably reflects the very busy nature of the main roads that run through our area.

There was considerable support for a range of methods to reduce the speed and volume of traffic, including more enforcement of speed limits. Many people preferred flashing signs to encourage lower speeds and were prepared to have traffic calming in the roads where they live or work.

1 in 3 pedestrians replied that they found difficulty in crossing roads in our area. There were suggestions for a range of measures to help pedestrian access and safety.

Interestingly, whilst many people considered traffic volumes an issue, 90% said they rarely, if ever, used public transport. The most cited reason was journey time and cost.

Over 40% of responses expressed a concern about obstructions on the pavements.



The Action Plan

The following Plan addresses the concerns, interests, preferences and wishes of residents as expressed in response to the consultations.

No single matter emerged that exercised the whole of the Downend and Bromley Heath community. However, there are key Issues which clearly arouse interest and feeling. The Action Plan is a summary of the concerns expressed and issues identified but the thousands of specific comments and responses about particular roads, paths and places are recorded and can be followed up in the future.

Most elements of the Action Plan involve working with partners such as Downend and Bromley Heath Parish Council, South Gloucestershire Council, the local Police, the Downend Business Community,

Neighbourhood Watch, local churches and voluntary organisations. Other groups will play their part in helping achieve the objectives in the plan and we will appreciate any suggestions you may have for partners not mentioned here.

Already residents and groups have volunteered to help in taking the Plan forward. Perhaps you have a particular interest in one of the issues. Your involvement and commitment will be most welcome; it could be as detailed or as brief as you are able to manage.

We would particularly appreciate the interest of younger members of the Downend and Bromley Heath community.

We do need more help in these groups. You will be welcome to join in and help shape the future.


The Community Plan Group will meet every three months to monitor and review progress and draw together what has been done so far. It will report annually on the implementation of the Plan.
